

Southwest Airlines Runway to Wrigley Sweepstakes ("Sweepstakes")

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID IN RHODE ISLAND, PUERTO RICO AND WHERE PROHIBITED OR RESTRICTED BY LAW. EXCEPT AS EXPRESSLY PROVIDED AS A PRIZE, TRANSPORTATION AND LODGING IS NOT PROVIDED.

- 1. Eligibility:** Sweepstakes is open to all legal residents of the fifty (50) United States and the District of Columbia (excluding Rhode Island) who are 18 years of age or older and have a valid email and Rapid Rewards account at the time of entry. It is free to enroll in Rapid Rewards (to enroll, visit www.southwest.com/enroll). Accounts are subject to its Rules & Regulations. Employees of Southwest Airlines Co. ("Sponsor"), the MLB Entities, their advertising and promotions agencies, and their immediate families (spouse and parents, children and siblings and their spouses) and individuals living in the same households of such employees are ineligible. All entries become property of Sponsor and will not be acknowledged or returned. Incomplete entries are not eligible. Individuals who do not follow all of the instructions, provide the required information in their registration, and/or abide by these Official Rules or other instructions of Sponsor may be disqualified. Entries must be received by August 5, 2026 at 11:59pm CST to be eligible. Entries limited to one (1) per person. Sponsor's computer is the official timekeeping device for this Sweepstakes.

No photocopied, mechanically, or electronically reproduced entries accepted. Automated entries are prohibited, and any use of automated devices will cause disqualification. Entrants may not enter with multiple email addresses nor may entrants use any other device or artifice to enter multiple times or as multiple entrants. Any attempt by any person found to enter or in any way attempt to obtain more than the authorized number of entries will be found to be ineligible, and their entries will be disqualified all as determined by Sponsor in its sole discretion.
